

### Vehicle Parking Registration Form 2020-2021

The increasing number of student drivers combined with the school's need to be able to quickly identify the owner of any vehicle parked on campus necessitates the registration of all student vehicles. Any student interested in obtaining a parking permit should read the information provided below and return this completed Vehicle Parking Registration Form to the high school secretary with a nonrefundable yearly \$20.00 registration fee.

1. Any student driving and parking his/her car on school property MUST register the vehicle(s) with the high school office and purchase a Parking Tag.
2. The student will be assigned a school parking space number which will be indicated on the Parking Tag.
3. The Parking Tag, which must clearly be displayed on the rearview mirror anytime the registered vehicle is parked on school property, will be issued to the student within five school days after returning this form and paying the fee.
4. **STUDENTS MUST PARK IN THEIR ASSIGNED PARKING SPACE. BLUE-LINED PARKING SPACES ARE FOR STAFF PARKING ONLY.**
5. Students are not permitted to park in unmarked spaces, along curbs, or in the grass.
6. If a tag is lost and needs to be replaced, the charge is \$10.00.
7. Students are not permitted to alter their assigned parking tag. Any student who alters a parking tag will be required to purchase another tag at the \$20.00 cost.
8. If the student is an Early Grad (graduates in January) they may turn their parking tag into the Main Office for a refund of \$10.00.
9. If a parking tag is purchased anytime after the first semester, the parking tag will cost \$10.00 for the remainder of the current school year.
10. A parking tag cannot be transferred to another student, including a sibling.
11. All vehicles being driven or parked on campus must obey all traffic signs and markings.
12. All vehicles driven to school must be registered with the Main Office. The office must be notified of any changes.
13. Students will be issued consequences for driving and parking infractions in accordance with the Lampeter-Strasburg High School Student Handbook.
14. Vehicles that are parked improperly or that do not clearly display a Lampeter-Strasburg Parking Tag may have a violation sticker applied to the upper right-hand corner of the driver's side window. It should be noted that the violation stickers are difficult to remove and the operator/owner of the vehicle is responsible for the removal and/or any car damage that may occur with removal.
15. If your parking space is utilized during a snow emergency, you will be permitted to park in the overflow lot.
